Colorado's largest Memorial Day Parade returns May 27

The city is thrilled to welcome floats, military organizations, horses, dancers, unique vehicles, and more to show their patriotic colors and honor those who have sacrificed for our country at the 58th Annual Commerce City Memorial Day Parade on Monday, May 27 at 9:30 a.m. This celebrated community tradition brings thousands of people to the heart of the city each year to gather along the 1.5-mile route, which moves west along E. 64th Avenue, travels past the Mile High Greyhound Park redevelopment, and finishes along Parkway Drive across from Veterans Memorial Park. Before the parade, the city will host a ceremony honoring our fallen service members at 8:45 a.m. at the Veterans Memorial on the north end of Veterans Memorial Park. 6015 Forest Dr.

Remember to stick around after the parade for a concert from Commerce City's own Those Crazy Nights, a Journey and 70s/80s arena rock tribute band, in Veterans Memorial Park from 11:30 a.m. to 1:30 p.m.! Featuring live music, food trucks, activities, booths from community organizations, and more, this is a great way to round out the parade.

Introducing the new MyC3 Yard of the Month Program

The city is introducing a new program to recognize those who demonstrate above-average efforts to maintain their property, improve the appearance of our city, and help build community pride! The new MyC3 Yard of the Month program will run June 1 – October 30 each year. All residential properties within Commerce City are eligible to win, but can only win once in a calendar year. Residents can nominate their own yard or another resident's yard. There will be one winner per ward (four winners total) every month during the program duration. Grants - April Update

Business/Economic Development



- Staff received an update on a proposed commercial development site along Tower Road. Some of the components of the proposed development include a hotel and up to three commercial pad sites. Staff advocated for new restaurants and food & beverage concepts.
- Staff reached out to an entertainment concept to discuss the possibility of a location in Commerce City. Staff is seeking to learn more about their space requirement and other development details.
- Staff attended and represented Commerce City at the Metro Denver Economic Development Corporation quarterly Front Range Economic Collaborative meeting.
- Staff received an update on a retail concept looking at the possibility of a location along E. 104th Avenue. Staff provided information on development in the area, housing developments and demographics.
- Staff received an update on a planned 4,500 square foot dental office located along E. 104th Avenue. They confirmed plans for building new stand-alone commercial building for office and supporting space for staff and operations.

- Staff assisted a company that provides electronic recycling services with alternative locations for their business and learned they signed a lease to occupy a building on 56th Avenue. The company is veteran-owned and provides about 20 jobs in our community.
- Staff met with another community in Colorado to research fiber-to-the-home service deployment in Commerce City. This effort supports Build C3 goals, and is also intended to appropriately respond to interest from a fiber-to-the-home prospect.
- Staff attended the Commerce City Chamber of Commerce Board meeting and gave an update on the Elevate Commerce program. The Chamber Board also approved a letter of support request from the city for a Farmers Market Application
- Staff met with the South Adams County Fire
 Department to strengthen partnerships on land
 development and business services. Staff and Fire will
 exchange more information on business services to
 support their annual inspection safety program.
- Staff provided business referral and land development business liaison services for an advanced manufacturer locating in Commerce City.
- Staff partnered with the grants division to garner data, draft a grant narrative and seek letters of support from community organizations for a Farmers Market. The grant would provide support and resources to develop strategies for vendor and producer recruitment, design materials for producer recruitment and support implementation plans
- Staff provided initial business retention and expansion services to an industrial gas manufacturing business that employees 100+ people in Commerce City. A business visit has been scheduled to learn more about the business and offer additional services.

DUI Driver Who Struck Two Commerce City Police Officers, Two Firefighters Pleads Guilty

Nearly six months ago four first responders, two South Adams County Fire Department firefighters and two CCPD patrol officers, were struck by a DUI driver who crashed through the scene of another completely unrelated DUI collision investigation.

It was a terrifying, horrific ordeal, and we are grateful all four survived, but one of our officers and one of the injured firefighters is still recovering.

On Wednesday, May 15, 24-year-old Benjamin Winters, the person responsible for this violent crash, pleaded guilty to a handful of charges.

Now that the Colorado State Patrol investigation is concluded, we have released a portion of the disturbing body camera footage from this incident

on our various social media platforms. It's edited, to protect the privacy of our injured officers and due to it's extremely graphic nature. Even this small snippet is difficult to watch, so viewer discretion is advised.



CCPD Command Staff, Local Businesses Celebrate Officers During National Police Week

Monday, May 13 marked the beginning of National Police Week, during which we recognize those who have chosen service before self. And on May 15, Peace Officer Memorial Day, we specifically remember those who lost their lives in the line of duty. So far nationally in 2024, that number is 58.

Yesterday, to thank the officers who protect and serve this community every day, the command staff and professional staff of the Commerce City Police Department held a cook-out at the police station. Most of the food items from burgers and hotdogs to fresh fruit and vegetables as well as desserts were donated by local businesses or paid for using funds provided by the Citizens Public Safety Advisory Board.

PW Updates

Preservation and Safety

The city was notified by the Colorado Department of Transportation (CDOT) that the Highway Safety Improvement Program (HSIP) grant application for 2027 was awarded in the amount of \$1,367,100. The city's match totals \$151,900 for a total project cost of \$1,519,000 The grant funds will be used to install Accessible Pedestrian Signals (APS) on several traffic signals in the Core City as well as replacing all the regulatory traffic signs (Stop, Yield, etc. signage) in the Core City. APS provide essential information to pedestrians who are blind or who have low vision by alerting them to the status of the walk cycle via auditory, visual, and vibrotactile cues.

Engineering

- Staff attended a weekly coordination meeting with the E. 96th Avenue Improvements project design team.
- Staff attended a Colorado Department of Transportation (CDOT) meeting for the Vasquez Improvement project.
- Staff participated in a weekly coordination meeting for the E. 72nd Place/Monaco Street intersection project.
- Staff attended an on-site construction meeting for the Colorado Boulevard project. Construction has begun and will be complete in nine to ten months.
- A weekly meeting was conducted for the E. 120th Avenue Widening project between Chambers Road and Buckley Road.
 The project is planned to be advertised for bids beginning the week of the 13th and opened by the end of May.
- Engineering staff met with representatives from Denver Department of Transportation and Infrastructure (DOTI) and Denver International Airport (DEN) to coordinate on the future E. 80th Avenue installation at Tower Road.

Parks Parks

- Parks teams were diligently working on maintaining our parks despite the challenges posed by heavy winds. Staff had to take swift action and cleaned debris and trash removal on right of way properties that were affected.
- Weed control measures were completed at Turnberry Park, Prairie Gateway Open Space, Second Creek Elementary, Turnberry Park and Bison Ridge Recreation Center this week. Staff applied herbicide in rock beds and various locations throughout each parks.
- Maintenance tasks extended to field care with all ballfields being dragged in preparation for field use throughout the week.
- Staff applied disinfectant to all playgrounds at Fronterra Park to ensure a clean environment for users.
- Irrigation inspections were executed, and necessary repairs or adjustments were completed at Olive Park, Adams Heights Park, Fairfax Park ballfields and Rose Hill Grange.



Streets

- This week, our Traffic teams replaced the thermal pavement markings on E. 104th Avenue and Chambers Road.
- Teams promptly responded to a report of two downed signs and successfully completed necessary repairs.
- Two flaggers were deployed to assist with traffic control during the Rosemary tree removal, managing the flow efficiently despite the single lane closure.
- Pavement teams removed and disposed of 60 tons of debris leftover from the E. 56th Avenue project completed last week.
- Teams also repaired a total of 47 potholes across various streets and graded Potomac, Peoria, and Roslyn this week.
- Looking ahead, preparations have begun for milling operations to install speed bumps in Buffalo Run.
